C. Course Description and Main objective

1. Course Description

This course covers the definition and basics of professionalism and the essential elements of the medical profession, including moral and ethical principles and legal responsibilities underlying the profession. It provides an overview of many ethical issues that arise in the practice of medicine and research and introduces students to the core elements of ethical reasoning around issues that they could encounter in their future practice.

Students will learn how to maintain and develop their competence, appropriately respond to ethical issues encountered in practice, maintain appropriate relations with their patients, colleagues and society and be empathetic to the physical and moral suffering of patients. They will learn giving effective feedback and working effectively within an interdisciplinary team.

The Islamic moral heritage represented by Quran and Sunnah is the reference framework in Saudi Arabian professional practice. The national and international guidelines and codes of ethics are explained in this course. The course approaches the Fighi-Legal aspects related to the practice of medicine and the conduct of research, like medical negligence, conflict of interests, and the rights of patients and research participants.

2. Course Main Objective

The main aim of this course is to introduce the students to the core elements of ethical reasoning around issues such as: confidentiality, truth telling, genetic testing, rationing, professional boundaries, conflicts of interest, informed consent for treatment and research, reproductive ethics, and end-of-life care.

3. Course Objectives

By the end of this course, students should be able to:

- Describe the principal approaches and frameworks of bioethics.
- Identify doctors' professional relationships & duties, and patients' rights & responsibilities.
- Demonstrate effective computer skills to navigate the web and search for the latest update on principles of ethics and professionalism.





- Apply principles of ethics and professionalism of the Islamic and Saudi framework to resolve ethical dilemmas in clinical scenarios.
- Collaborate with colleagues demonstrating presentation skills, group dynamics and teamwork competencies.
- Demonstrate lifelong learning skills and update knowledge, clinical and technology skills.
- Demonstrate skills of receiving educational feedback on performance.
- Prioritize Islamic and Saudi ethical and professional conduct in resolving clinical ethical dilemmas.
- Collaborate ethically and effectively with colleagues from diverse backgrounds.
