- Determine the process of ruling out and ruling in each of the differential diagnosis
- Prioritize the differential diagnosis list considering the demographic, social, and occupational characteristics of the patient.
- Design a comprehensive management plan Including all therapeutic modalities for disease prevention and health promotion
- Adhere to patient confidentiality
